## **RESPONSIBILITIES**

### **Employees recruited, hired and supervised**

When the Bureau was formed in 1983, no Ph.D. level professional had ever been employed in the Division's archaeological program. Resolving to raise the level of experience and expertise, I recruited and hired professionals with Ph.D. degrees to manage programs in historical archaeology, Spanish colonial history, underwater archaeology, prehistoric archaeology, preservation planning, conservation and collections management, and computerization.

### **Teaching and training**

Although hundreds of government employees are directly responsible for management of cultural resources on the more than 1 million acres of public land in Florida, virtually none of these managers have training or experience in protecting and managing archaeological sites. The Bureau of Archaeological Research and the Florida Park Service developed a three-day training program to teach non-specialists the fundamentals of caring for sites. Since this program was initiated in 1996, more than 500 people have completed the training, and cultural resources have attained a high level of visibility and care in many Florida land-managing agencies and non-profit organizations.
